

## OFFICIAL RULES FOR THE “CHAMPIONSHIP FAN GIVEAWAY”

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING**

**SWEEPSTAKES PERIOD:** The Championship Fan Giveaway (“Sweepstakes”) begins on March 9, 2020 at 12:01 a.m. Pacific Time (“PT”) and ends on November 1, 2020 at 11:59 p.m. PT (the “Sweepstakes Period”).

**HOW TO ENTER:** During the Sweepstakes Period there is one (1) way to enter: (1) visit the website <https://www.surveygizmo.com/s3/5481438/Championship-Fan-Giveaway-1> and follow the directions to enter into the Sweepstakes. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void.
